### **TERMS & CONDITIONS**

#### **SECURITY DEPOSIT**

The Renter must pay the Company a security deposit, first day's hire rate to secure the booking, payable only through direct deposit at the time of booking. The security deposit is refundable within (3) Business Day from completion of rental hire.

#### **RENT PAYMENT**

The Renter shall pay Kununurra Car Rental the full rental amount including the deposit prior to pick up.

#### **TERM & TERMINATION**

This Agreement shall be effective on the Effective Date and shall be terminated upon the end of the rental agreement once the vehicle has been returned in same condition as it was collected.

#### **LIMITATIONS**

The Renter shall provide copies of their valid driver's licence, additional drivers must also provide their valid drivers' licence details at the beginning of the hire period.

The Renter shall be aged 25 years or older, drivers of the vehicle must not be aged under 25.

The Renter shall not drive the vehicle off-road, included, but not limited to dirt roads, tracks, and fields.

The Renter shall not take the vehicle further than a 100km radius of Kununurra.

#### **DAMAGE & LOSS**

Any damage or loss resulting from the negligence of the Renter shall hold him liable for all repairs expenses and loss of income whilst the vehicle is un rentable.

#### **GENERAL PROVISIONS**

- The Renter shall return the vehicle with a full tank of fuel and provide proof of fuel purchase to The Company on return of vehicle.
- The Renter shall not be allowed to sublet the Rented Car for any reason.
- This Agreement is to be construed and governed in accordance with the laws of Australia.
